BAY STAR CONSIGNMENTS & MORE (Bay Star) is a resale shop specializing in quality women's' clothing, furniture, accessories, Persian rugs, and home accents. Our goal is to sell your consigned items quickly and for optimum prices. To achieve this goal, <u>WE NEED YOUR HELP!</u> The terms of this agreement are designed to best serve you, our consignor.

- 1. All clothing items must be delivered to Bay Star freshly laundered, pressed and on hangers. Complimentary hangers are available upon request. Non-clothing items (including accessories, furniture, etc.) must be clean, workable with no parts missing. A written list describing all items must accompany all consignments. Please make a duplicate of this list if you wish to maintain a copy for your records.
- Bay Star will only accept articles it considers to be fashionable, in season, and in excellent condition. Bay Star
  reserves the right to reject any articles. Rejected articles will be automatically donated to a local charity unless
  specified by the consignor. Consignors are responsible to pick up any articles not accepted for consignment within
  seven (7) days after delivery. After that date, articles will be considered donated.
- 3. Bay Star reserves the right to clean or repair items at a minimal cost to the consignor if we believe that the items will be enhanced in overall value and marketability.
- 4. Spring / Summer items are accepted beginning February 1<sup>st</sup>, and Fall / Winter items beginning August 1<sup>st</sup>. Most non-clothing items will be accepted year around. Consignments are accepted by appointment only. In order to keep our racks and floor space from becoming too full, we restrict the number of articles that can be brought in per appointment.
- 5. All asking prices will be determined by Bay Star. We reserve the right to periodically mark down the asking prices of the items. Consignors may pick up their unsold items at anytime during the consignment period. All asking prices of consigned items are subject to advertising promotions, buyers premiums, and discount coupons. Seasonal items consigned within one month of the seasonal change (Feb. 1st & Aug 1st) are subject to immediate price reductions. The "out date" for seasonal clothing items is 60 days from date of consignment and 90 days for non-clothing items and non-seasonal clothing items. Unsold items not picked up prior to their "out date" will automatically become the property of Bay Star and may be donated to a charity without notice. All items reduced and sold on a dollar table/rack will automatically become the property of Bay Star.
- 6. Consignors receive 40% of the selling price for all clothing and non-clothing items selling for \$100 or less per item and 50% for items selling for more than \$100. Payments are available at the shop after the 10<sup>th</sup> of every month for prior month's sales. Consignor accounts that have been inactive (no sales or paid outs) for over one year will be automatically closed and any monies remaining will become the property of Bay Star.
- 7. A \$5.00 annual service charge will automatically be deducted from the consignor's account.
- 8. Bay Star will make reasonable efforts to protect your consigned items, however, Bay Star will not assume any responsibility for items lost, stolen or damaged as a result of handling, fire, water, theft, or for any other reason.
- 9. The terms of this agreement is for one year from the date initiated and will include all items consigned during the initial period. This agreement will automatically renew each year unless cancelled by either Bay Star or the consignor within 30 days notice.
